eHealthTrust OPENS ARIZONA ELECTRONIC HEALTH RECORD BANK

Arizona Residents Can Now Have Complete Control Over Their Health Records With Automatic Updates

PHOENIX, Arizona (September 02, 2010)—eHealthTrust (www.eHealthTrust.com), an electronic health record bank, has opened its doors in Arizona giving residents access to its private and secure health record repository. eHealthTrust gives customers 24-7 online global access to their comprehensive health records, and automatically updates a member's medical history as it develops—unique to the healthcare industry. As part of its pre-registration launch in Arizona, eHealthTrust will offer a 30% discount (only \$69) in September.

<u>Dr. William Yasnoff, MD, PhD</u>, founder of eHealthTrust, is a nationally recognized industry leader, former HHS executive, and the founder and President of the non-profit Health Record Banking Alliance. "Phoenix is a perfect place to introduce a health record bank," Yasnoff explains. "Arizonans are serious about protecting their privacy and controlling who can access their information. But like all major metropolitan areas, Phoenix healthcare providers lack access to comprehensive electronic health records. We are excited about working

with the healthcare community to offer this missing piece to help reduce errors and duplication, and enable improved healthcare for Arizona."

Spearheading eHealthTrust's launch into the Arizona market will be its Arizona President and CEO Brad Tritle. As the need for healthcare providers to make the switch to electronic medical records (EMR) grows, eHealthTrust will also work directly with doctors to help ease the transition by providing EMRs at no cost.
